

## 2024-25 supervision training for psychoanalytic psychotherapists

## Closing date for applications 30<sup>th</sup> June 2024

## Eight Saturdays in-person from October 2024 to May 2025 at The Guild, 47 Nelson Square, London, SE1 0QA.

- An innovative training structured around different theories about the history and practice of psychoanalytic supervision.
- In-depth discussion of transference, ethics, boundaries & the constraints of working within different settings. Ongoing exploration of differences including class, culture, race, and sexuality.
- Emphasis on developing practitioners' own distinctive supervisory style.
- Suitable for experienced supervisors and more recently qualified clinicians.
- Equips students to apply for membership of the British Association of Psychodynamic & Psychoanalytic Supervisors (BAPPS).

In addition, there will be a weekend set aside for tutorials: 22/23 February 2025.

**2024-2025 fees**: Fees for the training are £2,475 (£2,200 for Guild Members). Fees exclude 15 hours (minimum) supervision of supervision, which is to be arranged by individual students. 18-months' subscription to PEP-web is provided for non-Guild applicants who do not already have access.

To be eligible to participate in the training, applicants are expected to have trained as psychoanalytic psychotherapists (meeting the requirements of either UKCP-CPJA or BPC) and must have a minimum of two years post-qualification experience. A separate document fully details the eligibility criteria. The course is designed to suit the needs of participants with varying degrees of post-qualification clinical and supervisory experience. Applicants whose applications meet the entry criteria will be selected following interviews which will be conducted online.

Applicants are required to offer group or individual supervision for the duration of the course. The supervision offered must be psychoanalytic in orientation, although the supervisees themselves need not be psychoanalytic psychotherapists. The Guild of Psychotherapists may be able to help in finding suitable supervisees, although this is not guaranteed. Early application is advised if this type of assistance is required.

**The course format:** The course will consist of eight seminars in person on Saturdays. Each of the seminars will comprise morning lectures followed by small supervision-of-supervision groups and a reading group studying the psychoanalytic literature on supervision. In addition, there are three individual tutorials. A minimum of 15 hours individual supervision-of-supervision (see requirements for the course). An optional 5,000-word essay is necessary to gain the diploma.

Requirements for the certificate of course completion (a diploma will be awarded where the optional 5,000-word essay is also completed):

- 85% attendance at the eight Saturday seminars. You are expected to do all the reading for the reading seminars and as much general reading as you can.
- three individual tutorials (with the course leaders).
- 15 hours individual supervision of supervision (or the equivalent in a group) with a psychoanalytic psychotherapist who has been qualified at least 5 years (to be arranged privately). It is expected that this supervision will be predominately in-person. You will need a letter from your supervisor of supervision saying that your supervision is of an acceptable standard. This letter will need to be received by the Guild Office before the last seminar of the course.
- A statement from the course leaders that your performance and conduct have been satisfactory.
